Thank you for your request of 11 August 2015. You requested the following information:

'I would like to request the period h arrivals and departures books for Edinburgh Newcastle, York, Leeds, London Kings Cross and Birmingham New Street and can i have them as adobe acrobat files please?'

I have processed your request under the terms of the Freedom of Information Act 2000 (FOIA).

I can confirm that we hold some of the information you requested.

Please find attached the platform arrivals and departures books for Edinburgh Newcastle, York, Leeds, London Kings Cross and Birmingham New Street. However for some of the stations we do not hold all the information you have requested.

The book for Birmingham covers period G and H. It is currently only available for Monday to Friday (SX). The plans for Saturday and Sunday are finalised and published on the Friday before the weekend so are not available in advance. The books for Leeds, York and Newcastle, are only complete up to 4 October and not for the full Period H. Beyond this date (at the time of your request) the information is not held. For Edinburgh only Monday to Friday (SX) and Saturday (SO) are available. Sundays are only finalised and published on the Friday before the weekend so are not available in advance. Each station has different plans for different days of the

week. To assist you, I have enclosed an explanatory guide with a key showing the days that trains run on

Please also note that on any given day at any given time the platform allocations may change due to unplanned operational incidents or planned events or engineering works.
