- Liable Party Name
- Property Address
- Rateable Value
- Property Description
- Billing or Correspondence address
- Liability Start Date
- Current entitlement to any Reliefs or Discounts (do not include details of any empty property reliefs)
- Start date of the entitlement to any current reliefs or discounts."

Your request is being considered and will be processed as soon as possible and certainly within the statutory timescale of 20 working days as defined by the Freedom of Information Act 2000 (FOI) and the Environmental Information Regulations 2004 (EIR) unless the information requested is subject to an exemption or contains a reference to a third party. Please note that under EIR the deadline can be extended to 40 working days for large or complicated requests.

The relevant legislation defines a number of exemptions/exceptions, which may prevent release of the information you have requested. There will be an assessment and if any of the exemption/exception categories apply then the information will not be released. There may be a fee payable for the information you have requested. This will be considered, and you will be informed accordingly. In the event of a fee having to be paid, the 20 working-day time limit or other relevant time limit for the response will be suspended until receipt of the payment.
