THE KINGSTON UPON THAMES AND RICHMOND UPON THAMES (20 MPH SPEED LIMIT) (NO.1) TRAFFIC ORDER 2008

Made:- 10th March 2008

Coming into force :- 17th March 2008

The Council of the Royal Borough of Kingston upon Thames, after consulting the Commissioner of Police of the Metropolis and pursuant to an agreement made under section 101 of the Local Government Act 1972(a) with the Council of the London Borough of Richmond upon Thames, in exercise of the powers conferred by section 84 of the Road Traffic Regulation Act 1984(b) as amended by section 8 of and Part I of Schedule 5 to the Local Government Act 1985(c), and of all other powers thereunto enabling, hereby make the following Order: -

- 1. This Order shall come into force on 17th March 2008 and may be cited as the Kingston upon Thames and Richmond upon Thames (20 mph Speed Limit) (No. 1) Traffic Order 2008.
- 2. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this Order the Kingston upon Thames (20 mph Speed Limit) (No. 5) Traffic Order 2003(*d*) is hereby revoked.
- 3. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on any road or length of road specified in the Schedule to this Order.

EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport.)

This Order imposes a 20 mph speed limit in the Tudor Area in the Royal Borough of Kingston upon Thames. The speed limit also applies to Beard Road, Cowper Road, Ham Ridings and Latchmere Lane (northern section) which lie within the boundary of the London Borough of Richmond upon Thames.
