We urgently need to get on the front foot on KX which, as discussed yesterday, risks turning in to blackfriars II. As at BF, we have a good story to tell but we need to tell it.

I'm currently up to my neck in horizon/2012 TDM but we need a plan to deal proactively with KX in terms of gla/assembly, external stakeholders, LB camden, the technical/design issues at the different junctions, consultation history, media etc etc.

In short we need a "narrative" for KX that we produced for BF but much earlier in the process.

Who needs to be involved and how quickly can we pull something together?
