Thank you for your recent email which was processed under the Freedom of Information Act 2000.

You requested the following information:

1. *Please supply clarification of the unit description used of “mg/kg”: is that milligram or micrograms, confirming that whichever it is, is applicable throughout?*
2. *Please clarify if 1. above relates to soil or water evaluation for arsenic.*
3. *Please give dates, source of any international contaminant levels taken into consideration in the risk assessments carried out of the above site including Plots 1 and 2.*
4. *Please inform if the values (unit of measurement) used in the September 2016 Risk Assessment correspond to the values (unit of measurement) used in the current limits and are considered acceptable. This information is asked as it is understood use of those values (units of measurement) used have been superseded by use of 10 exp -6 or 10 exp -9 . C*
5. *Please inform if the model used combines all reported contaminates figures as reported giving a single result used to describe risk to human, controlled water and gas risk receptors.*
6. *Please inform if contaminate interaction between any of the contaminates identified have been taken into account and if so how.*
7. *Please list caveats noted during modelling.*
8. *Data has been chosen to be excluded and described as ‘outlier/s’ please supply the excluded data*

Unfortunately Homes England does not hold the information that you are seeking.

To clarify, the report that you refer to has been produced by appropriately qualified consultants and contains the full level of relevant information that we hold. It would be inappropriate for Homes England staff, without the necessary expertise, to seek to further interpret this information.
