The section south of the road De138B is not part of the public footpath and is largely used for stock grazing, with farm buildings having encroached onto the northern section of the Dyke. Although the grazed sections are overgrown with scrub they do not appear to be in a worsening condition. There are some localised areas of erosion, but these seem to be through established routes, where there is no real alternative access.

The section to the north of the road De138A has mixed usage and a public footpath runs along this stretch of the Dyke. The southern fields are given over to crops and the Dyke is fenced on both sides. This does prevent the Dyke from damage, but it has allowed the Dyke to become very overgrown, although it is in a stable condition. Further north the Dyke is not fenced, but is part of a grazed field. The grass cover on the Dyke is good and there are a number of mature trees along the crest of the Dyke. The majority of these trees are in a stable condition. The main problem in this northern section is the stock access at the very northern end. However, at this point the Dyke is no longer evident. Generally this section is also in a stable condition.

I have visited sections of Offa's Dyke immediately to the south of De138 accompanied by lan Bapty and he is keen to establish some management agreements with the owner to the south also owns some of DE138B and it is hoped that any management agreement on sections of Dyke to the south would also include scrub management on the southern end of De138B.


Attached is an updated report outlining the progress with the Offa's Dyke damage case. I have included Alyson in case the Minister requires an update.

Archaeologists from CPAT will visit tomorrow to carry out an EDM survey and to cover and protect the exposed sections. They are not available to carry out the more detailed record until September because next week coincides with the Walton basin excavations which are time-restricted due to negotiated access arrangements. Once covered the damaged section of Dyke should be secure for the time being.

Contact has been made with the new owners and I am satisfied that they will not be carrying out any further work on

A press statement was issued last week which is still largely correct - wording included in my report below. The only substantial change could be to state that the police investigation is underway and Cadw has made arrangements for recording and protective measures to take place to prevent any further deterioration. I do not foresee the police concluding their investigation this week because some key interviewees are currently out of the country on holiday.





Offa's Dyke Damage DE138 Update 21st August 2013

Dr Kate Roberts, Snr Inspector of Ancient Monuments

Background

Offa's Dyke is a 1200 year old linear earthwork which runs through the English/Welsh borders from Treuddyn (near Wrexham in north east Wales) to Sedbury Cliffs (on the Severn estuary, in southern Gloucestershire).

The Dyke consists of an earthen bank which can be up to 8 metres high, associated with a ditch to the west, and typically occupies an imposing position in the landscape with fine and commanding views into Wales. It is not known exactly what the Dyke looked like when first built, but archaeological excavation suggests that the western side of the bank was revetted with turf to create a near vertical face, and it is possible that some kind of timber palisade or wall also existed on top of the earthwork.

Offa's Dyke is the most impressive monument of its kind anywhere in Europe, and a construction project of comparable landscape scale was not again to be undertaken for 1000 years, until the great canal schemes of the 18th century. It is one of the great engineering achievements of the pre-industrial age and the most dramatic built structure to survive from Anglo-Saxon times - as such it is crucial evidence of a key phase in British history which has generally left relatively few substantial visible remains.

Damage report

Timeline

On Monday 12th August Cadw was alerted that unauthorised works had been carried out within the scheduled area of a section of Offa's Dyke at Plas Offa near Chirk. Dr Fiona Grant, regional Field Monument Warden visited on 13th August and confirmed that the scheduled monument had been severely damaged by a mechanical excavator which had cut away half of the section of the dyke for a distance of c. 40m. It is a criminal offence to knowingly cause damage to a Scheduled Ancient Monument.

On 13/14th August Cadw initiated investigations to identify the owner of the land which we understood had recently changed hands. This included informing Welsh Government Legal Services who contacted the Land Registry and subsequently wrote to the new owner's solicitors who advised the owner to cease any works. Cadw Senior Inspector of Ancient Monuments, Kate Roberts informed Sgt Rob Taylor (wildlife and environment officer) of North Wales Police of the damage.

On 14th August Cadw's FMW returned to the site to erect a "Stop Notice" advising the owners that the site is protected by law and that all works should cease immediately. Two men at the site introduced themselves as the new

owners – they told the official that they had recently purchased the land and that it had been advertised as ideal for a paddock and stables. They stated that neither the vendor or their solicitor had alerted them to the protected status of the land. They agreed to cease all work immediately pending an investigation.

On 19th August Dr Kate Roberts and Dr Fiona Grant met representatives of North Wales police to hand over information in order to enable the police to commence their investigation of the incident. This included photographs of the damage, the damage report and names of the men believed to be the owners of the site.

On 20th August at the request of the police Dr Kate Roberts, Dr Fiona Grant and representatives of North Wales police met Mr Danny Roberts, the new owner at Offa's Dyke and inspected the damage with him. Also present was Mr Steven James, his friend who had assisted in the works which had resulted in the damage to the Scheduled Monument.

The owner expressed his shock at discovering that the land was protected and reiterated that he had not been aware of the scheduled status of the land until he was contacted by the Press and subsequently met the Cadw official. He agreed to cooperate fully with the investigation.

Police Investigation

A police investigation is now underway and Cadw staff are assisting with provision of information.

Initial indications are that :-

- a. the advertisement for the sale was misleading and represented the plot of land as "an ideal investment...ideal grazing or land for a pony with space for a stable to be erected'. In reality, all of the plot of land lies within the scheduled area and is therefore protected from development.
- b. Mr Roberts' solicitors carried out a local land search which identified the scheduled monument as a land charge; it is currently unclear whether this information was highlighted or its implications explained to Mr Roberts.
- c. Mr Roberts has stated that he informed the vendor and his solicitors that it was intention to build stables on the land and that neither indicated that there would be any difficulties preventing this.
- d. The vendor of the land was aware of the scheduled status of the land; Cadw records indicate that officials had met him on at least two occasions (1988 and 1993) and Cadw administration sent copies of the scheduled area map to his address by recorded delivery in 2000.

Please note, all of the above will be subject to formal verification by the police investigation.

Next Steps

The police investigation is still ongoing. We will wait to hear from them whether there is a case for criminal prosecution.

It is my view that the damaged Dyke needs to be repaired and restored to its original profile in order to maintain the integrity of the monument and prevent any future physical deterioration.

We have made arrangements for a full archaeological survey of the damaged and exposed sections of the earthwork to take place. This will be carried out by archaeologists working for the Clwyd Powys Archaeological Trust and will take place in two phases commencing with emergency recording on 22nd August 2013 after which the damaged sections of Dyke will be covered with tarpaulins to prevent any further damage, erosion or disturbance. Phase two will take place in September when the archaeologists are available to carry out more detailed study and recording of the damaged section.

Pending the outcome of this survey a decision will be made on the best means by which the dyke can be repaired and restored.

Press and Publicity Arrangements

The damage has come to the attention of the press and has appeared in several papers and a BBC television news report. Further press interest is likely to occur.

The following press statement has been issued:

"We are aware of the reported damage to a section of Offa's Dyke which is a nationally important ancient monument protected by law. An investigation is currently underway to determine whether or not an offence has been committed. The police have been informed."

Background information

- It's a criminal offence to damage Offa's Dyke under the Ancient Monuments and Archaeological Areas Act 1979
- Offences under the Act can be subject to a fine or imprisonment of up to two years.
- Offa's Dyke is a 1200 year old linear earthwork which runs through the English/Welsh borders from Treuddyn (near Wrexham in north east Wales) to Sedbury Cliffs (on the Severn estuary, in southern Gloucestershire).
- The Dyke consists of an earthen bank which can be up to 8 metres high, associated with a ditch to the west and is believed to have been constructed on the orders of King Offa of the Anglo-Saxon kingdom of Mercia in the 8th century AD to mark the frontier with the Welsh kingdoms to the west. The surviving earthworks of Offa's Dyke are

protected under law as a scheduled ancient monument including the stretch where the damage has taken place.



Dear Andrew.

I understand that Paul has moved on and that you will be taking the reins for the above project. I apologise for an unavoidable delay on my part in providing the below comments on his draft.

The draft proposes a sensible and not overly complicated approach and is in general fine but there are a few issues, the first

1. Indicative costs. As initially requested we will need the proposed scheme to be costed up, if only very broadly. This was the primary purpose of this commission as Cadw will be handing this report to the landowner and his present solicitor both to inform the reinstatement of the monument and acting as a guide to claim costs incurred. Another copy will be sent to planners officers at Wrexham CBC, who will incorporate this information into an enforcement notice.

I'd passed Paul the contact details of Paul Fairclough from Wrexham Highways dept - paul.fairclough@wrexham.gov.uk who has indicated to me that a range of graded potential fill materials could be donated for free if whoever does the work provides the transport. I'm not sure whether the conversation took place but it would be worth clarifying the logistics of this and including in the text - reduced costs are likely to increase the chances of the owner actually undertaking these works. If the offer sounds feasible / appropriate the possibility should be flagged up in the report.

2. Could you add in an early paragraph that 'all reinstatement or restoration works will require Scheduled Monument Consent from Cadw' rather than. We can then send the owner a copy of the application form with the final copy of the report.

- 3. Whilst we are used to reading and understanding this sort of document the landowner will have difficulties. Could you also add a brief non-technical summary? He can let his contractors deal with the technical aspects.
- 4. Section 530. Machines / vehicles access. Perhaps also stress that works should not be undertaken during a wet period in order to avoid the already very soggy backfilled ditch which access is gained from becoming a swamp. Site access may be better tackled as a separate section.
- 5. This might sound picky at this stage but under sections 525 and 525A my policy colleagues have asked if you remove the Opus reference for now as this could be construed as Welsh Government suggesting a contractor to the owner. This ultimately has to read as a stand alone report with recommendations for his consideration.

Do give me a ring to discuss – I'm out for a couple of days now but in again on Friday (my mobile is being repaired so it'll have to be the office).
