Subject: CAMS-012-33955459-8 Serious Data Protection Breach - Salford City Council

Information Commissioner, Salford City Council Data Protection Officer,

I am a volunteer administrator of the website WhatDoTheyKnow.com which enables people to make Freedom of Information requests in public.

Salford City Council have, today (18 September 2018) alerted us to the accidental release of personal information in their response, of 31 August 2018, to the Freedom of Information request at:

https://www.whatdotheyknow.com/request/gdpr and appropriate adults 13

What has occurred appears to be a very serious data protection breach by the council, in which the council has released a completed form used for recording the provision of an appropriate adult at a police interview involving young people; the young people, two of them, have been clearly identified.

While the incident only appears to involve personal data relating to two people, the content appears to be highly personal/sensitive and it is for that reason we consider what has happened to be serious.

We have acted to prevent the requester and the public having further access to the released document.

We at WhatDoTheyKnow don't have the resources to fully investigate and understand what has happened, it may well be that investigations show that the occurrence is not as serious as it appears.

We consider the council should report this occurrence to the Information Commissioner, and take action to ensure such an event cannot happen again. If the Information Commissioner does not receive a report from the council we suggest the commissioner contacts the council to make inquiries.

We at WhatDoTheyKnow intend to hold the information for a further four weeks so that it is available to support any investigation. Please do let us know clearly if the information is not required from us, and if it is, please propose a secure means of transmission.
