### Re: Freedom of Information (Scotland) Act 2002 - Request for a Review

I am responding to your request to the University, received by email on 21 September 2019 timed 1529 hours, for a review of our response to your original request for information on admission data. I have reviewed your request and our response and will take each of your points in turn.

## "1. The offer rates provided in Appendix A do not always add up to 100%. This seems odd ..."

Our interpretation of your request for information on offer rates was the offer rate by cohort. For example, for the LLB in 2016,

69% of Scottish applicants 40% of EU applicants 46% of RUK applicants and 42% of International applicants

received offers.

# "2. I believe that the s.17 ground for the refusal does not apply to Questions 7 and 8 in my request."

I have reviewed our response and sought clarification on the data we hold. I can confirm that the University does not hold the data you have requested on entry tariff — your request would require the creation of new information, therefore I conclude that the s.17 exemption was the correct response.

The supply of documents under the terms of the Freedom of Information (Scotland) Act 2002 does not give the applicant or whoever receives the information any right to re-use it in such a way that might infringe the Copyright, Designs and Patents Act 1988 (for example, by making

multiple copies, publishing or otherwise distributing the information to other individuals and the public).
