Your Request for Information

I am writing in response to your recent request that we received on 25 January 2018, in which you requested the following information under the Freedom of Information Act 2000.

Information Requested

Under the FOI act, could you kindly please provide me with a current list of the email addresses of all Practice Managers within your CCG and the relevant GP surgeries they manage.

I will not be publishing the information you provide to me and will only use it to send information about a medical service that may be of interest to Practice managers.

Response

I can confirm NHS Hull Clinical Commissioning Group (CCG) holds the information you have requested.

Some of the information you have requested is exempt under Section 21 of the Freedom of Information Act 2000 (FOIA), because the information is reasonably accessible to you, as it is already in the public domain. Please see attached a list of

current practices in NHS Hull CCG and their respective websites which contain contact details of practice managers.

Where the requested information is not available in the public domain the CCG considers the information is exempt from disclosure under section 40 (personal information) of the FOIA, as the information constitutes third party data. Section 40(2) provides that personal data about third parties is exempt information if one of the conditions set out in section 40(3) is satisfied. Under the FOIA disclosure of this information would breach the fair processing principle contained in the Data Protection Act 1998 (DPA), where it would be unfair to that person or is confidential.

The CCG provides the names of members of staff who are graded as Agenda for Change Band 8 and above due to the senior nature of these posts, their significant level of personal judgement and their individual responsibility on behalf of the CCG. However, in relation to Practice Managers the CCG does not hold information on pay band or rates.

The CCG does however have a Practice Manager representative as a member of the CCG Board (details below). It is suggested that the Practice Manager representative is contacted and he will be able to advise on an appropriate way of providing information to the Practice Managers of the CCG's member practices.
