### **Freedom of Information Request**

Thank you for your e-mail of 14 May requesting information under the terms of the Freedom of Information Act 2000 (FOIA).

You asked:

Please supply figures for the number of requests from foreign countries, include the Channel Isles and Isle of Man, for both driver and vehicle information.

Please supply figures for the number of requests made to foreign countries, include the Channel Isles and Isle of Man, for driver and vehicle information.

Please include the years 2008/9/10 in the report and identify the countries.

The Agency may in exceptional circumstances share information with certain authorities outside of the UK. These circumstances are stipulated in legislation.

Under the EUCARIS Treaty 2000, DVLA shares vehicle information via the European Car and Driving Licence Information System (EUCARIS) to establish whether exported vehicles have been reported as stolen or scrapped. This enables registration authorities to be alerted prior to re-registration in the country of import. EUCARIS also provides for an exchange of driver licence information which enables the validity of licences from participating countries to be checked prior to exchange, ensuring the licence presented for exchange is the most recent and accurately records information on entitlement and endorsements etc.





Currently, the UK may make enquiries via EUCARIS on 10 other Member States for vehicle data. These are: Belgium; Germany; Estonia; Hungary; Luxembourg; Lithuania; Latvia; the Netherlands; Romania and Sweden. In relation to driver data, the UK may make enquiries on 5 other Member States, these are: Germany; Estonia; Luxembourg; Latvia and the Netherlands.

The Agency does not collate statistics relating to the number of requests made to and by the UK. However, please find attached two tables taken from the EUCARIS Statistical Report for January – June 2009. The first table provides an overview of the total number of enquiries for 2008 and 2009, and the second provides a breakdown of the number of enquiries made in and by participating Member States between January and June 2009. Unfortunately, the Agency does not hold any further statistics on this. The recent 2010 statistics are available on the EUCARIS website at www.eucaris.net/statistics

In addition to the above other enquiries may be made under the Road Safety Act 2006 or the Crime (International Co-operation) Act 2003. Again, there are no statistics held on the number of enquiries made under either legislation.

The information which follows concerns the copyright conditions that apply to any information provided by the Agency and the procedures for making any complaint you might have about the reply. Please quote the reference number of this letter in any future communications about it.

## **Complaints**

If you are unhappy with the way in which your request for information has been handled, about the decision not to disclose all or part of the information requested and/or that the DVLA has not complied with its FOI publication scheme, you have the right to complain within two calendar months of the date of this letter. You may complain by writing to the Freedom of Information Team, DSPG/FOI, D16, DVLA, Swansea, SA6 7JL or e-mail foi@dvla.gsi.gov.uk.

Your complaint will be acknowledged and you will be advised of a date by which you should have received a response. Initially, your complaint will be re-considered by the official who dealt with your request for information. If, after careful consideration, that person decides that his/her decision was correct, your complaint will automatically be referred to an independent official who will conduct a further review (an Internal Review). You will be advised of the outcome of your complaint and if a decision is taken to disclose information originally withheld this will be done as soon as possible.

If you are not content with the outcome of the Internal Review, you have the right to apply directly to the Information Commissioner for a decision by writing to the Information Commissioner's Office, Wycliffe House, Water Lane, Wilmslow, Cheshire, SK9 5AF.
