Thank you for your Freedom of Information (FoI) internal review request received on 30 July 2015. Please accept my apologies for the delay in replying. You asked:

## You said:

- "• DWP We share all the information with the LA regarding existing and closed legacy benefits that is relevant to the LA for the claimant(s) only.
- LA DWP and HMRC data is provided to LAs by DWP for the limited purposes of administering HB, and any specific service or provision of a prescribed welfare service or local council tax reduction scheme. Currently this is limited to: Housing Benefit

Local Council Tax Reduction schemes (LCTR) Local welfare provision (LWP). " You firstly define the sharing info from DWP as claimant (s) only but when it comes to LA you don't mention anything about claimant(s) only restriction.

How can I read it? Can I understand "DWP and HMRC data is provided to LAs by DWP" also claimany(s) only? If it includes the non-dependant(s) information, then it sounds contradicting.

In response to your request, I can confirm that the handling of your original request and response has now been appropriately reviewed and that I was unconnected with the handling of your original request.

As a result of this review I find that the original decision was not correct and as such your request for review is upheld. The information that you request is therefore as follows:

In answer to the questions you have raised, Universal Credit (UC) currently collects the following information on non-dependants:

- First Name
- Middle name
- Last Name
- Date of Birth
- Gender
- Relationship to the claimant(s) We ask this if the none dependent is away on ops with armed forces and if child or step child)
- Are they in education?

- When did they start education?
- Is the none dependent responsible for a child under 5
- Does the non-dependent receive any other benefit
- Is the none dependent in the armed forces
- 2. Automatic Data sharing for UC non dependents.
  - HMRC Universal Credit does not routinely receive or share information from HMRC in respect of non-dependents.
  - DWP Universal Credit does not routinely receive or share information regarding the benefits that non dependents in a UC household claim and therefore does not share this information.
  - LA UC data and HMRC data on none dependents is provided to LAs by DWP for the limited purposes of specific services or provision of a prescribed welfare service or local council tax reduction scheme. Currently this is limited to:
    - Housing Benefit
    - Local Council Tax Reduction schemes (LCTR)
    - Local welfare provision (LWP).

In UC this is limited to the non-dependent information that we collect. We share the information in cases where there is a valid claim for LCTS or they intend to make a claim whilst making a claim to UC.
