Freedom of Information Act 2000

This request is being handled under the Freedom of Information Act 2000.

Your request states:

- 1) How many children, who were known to your social services department, died between 1st January 2017 30th November 2021? (Including those dates)
- 1i. Please specify how many of those occurred in each year 2017, 2018, 2019, 2020, 2021.
- 1ii. Please provide the ages of the children, and the cause of death.
- 2) How many children, who were known to your social services department, were admitted to hospital with malnourishment

between 1st January 2017 - 30th November 2021? (Including those dates)

2i. Please specify how many of those occurred in each year - 2017, 2018, 2019, 2020, 2021.



2i. Please provide the ages of the children.

Please provide the dataset in an Excel format.

The Council's response

The requested information is not held in a readily retrievable format and there is no automated mechanism for the collation of the required data. Therefore, provision of this information would require manual review and processing of a large volume of data, considerably exceeding the limit to time and resource under FOIA.

The Freedom of Information and Data Protection (Appropriate Limit and Fees)
Regulations 2004 has set the appropriate limit as £450 based on a charge of £25 per hour. Section 12 of the Act states that the Council is not obligated to comply with a request for information if the authority estimates that the costs of complying with the request would exceed the appropriate limit.

Also, as you may be aware, in October 2020 Hackney Council experienced a serious cyber-attack, which caused a significant disruption to our delivery of day-to-day services. Consequently, the Council holds limited information prior to October 2020 and post 2020 our current interim system does not allow us to report on your above request.
