## **Re: Freedom of Information Act 2000**

Thank you for your emails of 17<sup>th</sup> February 2020 in which you requested the following information from the Insolvency Service:

1. I would like to know how many...

- liquidation (applies to a limited company or partnership)
- administration (applies to a limited company or partnership)
- company voluntary arrangement (applies to limited companies)

... have been made to each county and unitary authority from 2000 - present.

2. I would like to know how many Debt Relief Order's (DRO's) have been released from 2000 - present, including by county, region, gender, and unitary authority.

Your request has been dealt with under the Freedom of Information Act 2000 (FOIA).

### **Question 1**

The Insolvency Service does not hold the information you have requested.

However, it may be useful for you to know that we do publish numbers of company insolvency statistics which can be accessed using the link below.

Please note FOIA only applies to recorded information, it does not require public authorities to answer a question unless recorded information exists. Therefore, to

## **Question 2**

I can confirm the agency holds the information that you have requested however, the information you have requested is exempt from disclosure under section 21 of the Freedom of Information Act 2000 and is therefore refused.

Section 21(1) provides that information which is reasonably accessible to the applicant otherwise than under section 1 is exempt information.
