Dear Fern Valentine.

Thank you for your Freedom of Information (FoI) request received on 24 January. You wrote:

"How would one go about accessing a family members DWP records regarding JSA and ESA claims including all correspondence logged via telephone and letters. I am the deceased's daughter and Next of Kin and I have all forms of ID for myself and the deceased. I understand there could be a charge for this, if so could you tell me how much this would cost."

## **DWP Response**

Let me first send my deepest regards for the passing away of your late father.

The Department for Work and Pensions (DWP) treats personal information about deceased persons with a strict duty of confidentiality. We will only disclose personal information about a deceased person with the signed written consent of the administrator or executor of the deceased person's will or where ordered to disclose by a court.

We consider personal information about deceased persons to be exempt from disclosure under both Section 41 and Section 44 of the Freedom of Information Act 2000.

Section 41 relates to information provided in confidence. Section 44 allows for information to be exempted where there are prohibitions on disclosure, e.g. other legislation prohibits disclosure. Section 123 of the Social Security Administration Act 1992 allows that any unauthorised release of personal information (including that of a deceased person) gathered for Social Security purposes would be a criminal offence.

We will only provide your late father's personal information to you if you can provide proof that you are the executor or administrator of his will or if you provide signed written consent from the executor or administrator of his will.
