Thank you for your request under Section 1a of the Freedom of Information Act.

I can confirm that we hold the information that falls within the description specified in your request.

The following answers correspond to the points made in your request

Could the authority state how they use agencies and/or software to expedite the discharge of DTOC patients?

• We use a Clinical Utilisation tool called Medworxx. It is a Canadian system that allows us to establish whether patients are appropriate for the acute bed base. This is achieved by using Internationally approved Clinical Criteria and thus removes subjectivity from the decision making process. From this information - we can extrapolate our Delayed Transfers of Care. Using the data from the system, we're able to produce many reports (both Operational and Strategic) to escalate and resolve issues with the discharge process. The information is shared widely with both internal staff and our community partners (Liverpool City Council, Liverpool CCG, Mersey care, out of Area councils etc.)

How much did they spend with agencies to arrange placements with care homes or home care for DTOC patients in each of the last three financial years?
