I received this the below from the policy team. Overall (as in the entire £250 million which includes the vouchers) the split is 70 capital and 30 revenue. We would urge them to capitalise as much as possible as the revenue will run out quickly. We would imagine that the first tranche is more suited to revenue e.g. paying someone to put out cones/planters etc but we aren't prescribing it. 
