

Successful in country applications: 9,443 Unsuccessful in country applications: 2,712 Applications still under process: 299

4) Of the out of the country applications, how many were successful and how many were unsuccessful and how many are still under process?

Successful out of country applications: 1704 Unsuccessful out of country applications: 3296 Still being processed: 96

5) Of the applications from Pakistan, how many were successful and how many unsuccessful and how many are still under process?

129 were appealed against, 18 were successful and 64 were unsuccessful.

- 5) Of the applications from Pakistan, how many were successful and how many unsuccessful?

172 were successful and 155 were unsuccessful.

6) Of the unsuccessful applications from Pakistan, how many applications were appealed against and how many appeals were successful and how many unsuccessful and how many are still being processed?

117 applications were appealed against, 42 were successful and 26 were unsuccessful. 49 are still being processed?

7) Of the unsuccessful applications from in country, how many applications were appealed against and how many appeals were successful and how many unsuccessful and how many are still being processed?

660 out of 1,035 unsuccessful applications were appealed against

8) Of the unsuccessful applications from out of the UK, how many applications were appealed against and how many appeals were successful and how many unsuccessful and how many are still being processed?

1216 applications were appealed against, 534 appeals were successful and 464 appeals were unsuccessful. 218 appeals are still being processed.

Please note that this data is based on management information. It is provisional and subject to change.

I hope that this information meets your requirements. I would like to assure you that we have provided you with all relevant information that the Home Office holds.
