Freedom of Information request (our ref:31775): internal review

Thank you for your e-mail of 27 June 2014, in which you asked for an internal review of our response to your Freedom of Information (FoI) request about the destruction of biometric information about the family member of an EEA National.

I have now completed the review. I have examined all the relevant papers, and have consulted the policy unit which provided the original response. I have considered whether the correct procedures were followed. I confirm that I was not involved in the initial handling of your request.

My findings are set out in the attached report. My conclusion is that the response correctly informed you that the Home Office did not hold the requested information, and provided you with a link to the website where it could be accessed: however, it should have provided the title of the relevant legislation, and guidance on how it could be found. For further explanation, see paragraphs 4–10.

Chronology

Original Fol request: 16 May 2014

IIPG response: 16 June 2014

Request for internal review: 27 June 2014

Subject of request

 The request asked for information about the retention of biometric data about family members of EU nationals. For the full text of the request see **Annex A**.

The response by IIPG

2. The response informed Amit Hidri that the Home Office did not hold the requested information, and provided a link to legislation.com where details of all legislation can be found.

The request for an internal review

3. The internal review request asked for guidance on how to access the relevant legislation on legislation.com, and challenged the statement that guidance on the subject was not held by the Home Office. The original IR request dated 16 June was not received in the Home Office, as it was sent to the 'FOI responses' inbox, which does not accept incoming emails.

Procedural issues

- 4. The Home Office received Amit Hidri's request via email on 16 May 2014.
- 5. On 16 June 2014 the Home Office provided Amit Hidri with a substantive response, which represents 20 working days after the initial request. Therefore, the Home Office complied with section 10(1) by providing a response within the statutory deadline of 20 working days.
- 6. The response confirmed that the Home Office did not hold the requested information, but that it was available by other means. A link to the relevant website was provided.
- 7. Amit Hidri was informed in writing of the right to request an independent internal review of the handling of his request, as required by section 17(7)(a) of the Act.

8. The response also informed Amit Hidri of the right of complaint to the Information Commissioner, as set out in section 17(7)(b) of the Act.

Consideration of the response

9. IIPG informed Amit Hidri that the requested information was available via the legislation.gov website, and provided a link. It would have been helpful to have provided the title of the legislation in question, and guidance on how to find it on the website.

Conclusion

- 11. The response was sent within 20 working days; consequently the Home Office complied with section 10(1) of the FOI Act.
- 12. Section 1(1)(a) was complied with, as the response clearly stated that the requested information was not held.
- 13. The response complied with the requirements in section 17(7)(a) and 17(7)(b) as it provided details of the complaints procedure.

Annex A – full text of request

Dear Home Office,

Can you please provide me with current guidance relating to the destruction of Biometric Information about the family member of an EEA National.

I understand that the Home Office cannot legally retain such information without the approval of the person, as to do so would breach Article 8 and 14 of the ECHR (as they are not Persons Subject to Immigration Control).

Annex B – full text of response letter

FOI reference 31775

Thank you for your e-mail of 16 May 2014, in which you ask for current guidance relating to the destruction of biometric information about the family member of an EEA National. Your request has been handled as a request for information under the Freedom of Information Act 2000.

The Home Office does not hold the information which you have requested. There is no specific guidance about the destruction of biometric information about the family member of an EEA national.
