Thank you for your email of 12th September 2018, in which you requested the following information:

'Under the Freedom of Information Act, I am requesting information on the "787 incidents of dangerous behaviour in 18 days" that were recorded in the Cotton Mill Lane railway crossing in St. Albans, Hertfordshire, according to a sign posted on an entrance to the crossing.

Please provide the information in an Excel spreadsheet, showing at least the following:

- -Date of incident
- -Time of incident
- -Type of incident
- -Description of incident'

I have processed your request under the terms of the Freedom of Information Act 2000 (FOIA) and confirm that we hold the information you have requested.

In response to your request, please find attached copy of 'Cotton Mill Lane Census Incidents v3'.

To provide a little additional detail, there were in fact 845 reportable incidents not 787, as per the recent campaign. I understand this is because the figure of 787 did not include certain categories of incident including users not dismounting on bikes,

pushchairs becoming stuck on the rails and extraordinary incidents such as trespassers and users spending prolonged periods of time lingering on the crossing.

Over the next few weeks, this page will be updated to include an explanation of Network Rail's concerns about the different types of behaviour reported in the attached. It will also feature a number of video clips by way of illustration.
