- 5. Why did Cllr Munby get Cllr Gary Millar involved into this project in 2014/15?*
- 6. On on the 13th May 2019 did the Liverpool city council or Mayor Joe Anderson, tell Cllr Steve Munby to hold talks with the residents of Liverpool 8 in regards to the land known as the (Flat- Irons)*
- 7. Why was Cllr Munby acting for the Elliot group who wish to put a building on this land?*
