#### You asked us to provide the following information:

- The names of any hospitals (including any secondary care provision such as community or mental health) that fall under your control.
- 2) Whether any of the aforementioned bodies use digital dictation and/or Speech Recognition. If so which organisations use what systems?
- 3) If none are used or they are only used in some areas, are there any plans to implement these type of systems more extensively to increase efficiency and improve patient care?
- 4) If Systems are already in place, when are they to be reviewed?
