- a. who is the specific person/people responsible for approving the specific designation of a Tutor when a postgraduate student enters/continues studying in College
 - Students who were undergraduates of the College usually remain on their same tutorial side throughout.
 - New graduate students who come from outside Cambridge are allocated to Side F. Side F1 and F2 alternate, admitting a full new cohort each year.
- b. I would like to know whether communication with the student takes place to assign a suitable Tutor, to facilitate 'close interest in students' academic progress and welfare' of a Tutor that is listed in the White Book 2019/2020
 - Side F students are allocated as explained above. Students on other sides are allocated a tutorial side on undergraduate admission by the Undergraduate Admissions Tutor, taking into account subject area and other criteria.
 - Graduate students are also allocated a College Contact with a particular interest in their subject area.
- c. I would like to know under what circumstances a change of Tutors can take place, whose responsibility it is to deal with such request, how this request should be dealt with and who makes the ultimate decision to grant/reject a request and under what grounds. This information is not listed in the White Book 2019/2020 and is not in the public domain.

The College does not have a formal procedure or set criteria for reallocation of tutors. Requests for reallocation are considered by the Senior Tutor when received.

8. whether Trinity College has a disability specific adviser. I note Trinity College has a Fellow for Trinity Women, Fellow for LGBTQ+ and Fellow for Ethnic Diversity. However, I struggle to identify any specific and trained disability adviser allocated to aid disabled students and staff.

This is the responsibility of each tutor in the first instance who will help students to access specialist support, as needed. The tutorial staff are generalists and leave the specialised work to trained experts. Given the diversity of conditions covered by the term 'disability' the College has adopted a carefully targeted approach involving trained professionals and therefore does not have a generic post of 'Fellow for students with a disability'.

First, for those with serious mental health issues, the College employs a full time professionally trained Mental Health Advisor, the first college to do this.

Second, the College also benefits from the services of a part-time employed counsellor.

Third, the College employs a senior nurse with the relevant professional qualifications.

Fourth, the Tutorial team work closely with the College's allocated contact at the University's Disability Resource Centre (DRC), for which Trinity like all colleges provides financial support – a Senior Disability Adviser (SDA) who offers specific advice and support to students with a range of disabilities including Aspergers, physical disabilities, long term health difficulties, and hearing and visual impairments. She works with colleagues who offer support to students with Specific Learning Difficulties such as Dyslexia, ADHD and Dyspraxia.

Given the importance the College attaches to the support provided by the DRC, the SDA comes in person to college every fortnight to hold drop-in sessions. She is available to tutors as well as students. She can assist with Student Support Documents which outline the recommended support that can assist students in various ways.
