Thank you for your request for information received on 25th January 2017. Please find the response from Cwm Taf University Health Board set out below:

You asked:

Please can you supply me a copy of the criteria document in force during 2008 for the provision of specialist medical beds to disabled children?

Our response:

I can confirm that the only criteria that we hold in relation to the provision of specialist medical beds to disabled children, is from 2010 and is currently still in use (please see attachment 1). Prior to 2010, there was not a separate criteria for children. However, to aid and assist you with your request please see attached the criteria for provision of profiling beds which was in force during 2008 (attachment 2).
