## **Response**

**1. How many Birmingham City Council Properties have been adapted by the council to MOB 1 standard since 2010?**

From 1 April 2016 to date, Birmingham City Council have adapted 687 properties to MOB 1 standard. Birmingham City Council does not hold data before this date.

**2. How many MOB 1 standard adapted properties are currently on the councils housing stock?**

- 130

**3. How many MOB 1 standard adapted properties that are available for rental by disabled persons under 50?**

**4. How many MOB 1 standard adapted properties that are available for rental by disabled persons over 50?**

6 of the 130 MOB 1 standard adapted properties are reserved for people over 50, disabled or otherwise.

**5. How much has BCC spent on adaptations since 2010?**

Birmingham City Council has spent approximately £76,250,000 on adapting properties since 2010. This includes adaptations to council and privately owned properties, and adaptations funded through Disabled Facilities Grants.
