What will happen when we've made our decision?

We will write to you again as soon as we've looked at all the information we have, to tell you our decision.

If we decide you've done what's required, we will pay any Jobseeker's Allowance you are due for the time it was stopped.

If we decide you haven't done what's required, we won't pay Jobseeker's Allowance for the time it was stopped, and your claim will close.

If you made a joint claim for Jobseeker's Allowance, you must share this information with your partner.

If your claim is closed

This will affect your Housing Benefit and Council Tax reduction so contact your local council straight away. They'll tell you what you need to do next.

You can make a new claim for Jobseeker's Allowance but you must be available for work and ready to do all you can to find work.

Jobseeker's Allowance might not be paid at the start of a new claim for up to 4 weeks. This could increase to 13 weeks if your benefit has already been stopped in the last 52 weeks. We call this a sanction.

A claimant commitment is a Jobseeker's Agreement for the purpose of section 1(2)(b) of the Jobseekers Act 1995.
