As set out in the addendum the lump sum payments now due should be made to:

“Current Primary Beneficiaries infected with HIV (including those categorised as co-infected) to bring the total received, including that paid by AHOs, up to £80,500.”

So yes, the holistic amount paid previously should be used to calculate what is now due. The same principle applies to the Hep C payments.

As discussed, please can you consider the following and confirm please.

I have a point of clarification that was raised with us by Russell-Cooke, that relates to the monies previously paid to beneficiaries, that should be confirmed by them to us, in order for us to make the correct lump sum payments.

The question they have asked relates to whether they should provide us with the amount a person has been paid as a 'waiver payment', the payments that DHSC paid out previously that required beneficiaries to sign that they accepted the money without any entitlement to further support.

Historically EIBSS has always taken into account the holistic lump sum amount they've previously received from an AHO, when a person has come forward who was supported by an AHO. EIBSS has not considered the type of payment just considered the total amount and compared that amount to the entitlement figure stated in the specification, to ensure they're paid the full amount.

EIBSS believes this point mainly applies to those infected with HIV, where the top-up amount to the £80,500 is due.

I would greatly appreciate your view on this ASAP, as Russell-Cooke are in the process of gathering the information and we want to ensure they include all of the required information, so that's EIBSS can calculate the lump sum payments for this group correctly.
