#### **RE: FREEDOM OF INFORMATION REQUEST**

I am writing in response to your request for information under the Freedom of Information Act 2000 received on 20 November 2012 by one or all three of the three primary care trusts in NHS Kent and Medway.

All answers relate to NHS West Kent, NHS Eastern and Coastal Kent and NHS Medway unless otherwise indicated. The information that you requested is listed below together with a response in each case:

# How much did the PCT spent in the last 3 years on the dispensing cost (excluding drug costs) by (a) pharmacies (b) GPs.

a) The NHS Business Services Authority (NHSBSA) tell us how much we are expected to pay towards the total cost of Community Pharmacy services but that includes other areas apart from dispensing. The total time to break this down any further would exceed 18 hours, therefore we are exempting this part of the request under Section 12 of the Freedom of Information Act 2000.

The Act provides an exemption where the cost of compliance is estimated to exceed the appropriate limit. The Freedom of Information Act allows for a reasonable period of time to be spent on responding to requests. Taking into consideration your request, in its current form, would take us beyond this limit.

Similarly, a lot of the costs for these areas are "fair shared "across the country and therefore we only pay our "fair share" of national costs (East Kent fair share is 1.37%, West Kent is 1.25% and Medway is 0.47%).
