I am writing with regards to your request for a review, which we received on 6 July 2016. In your original request you asked for:

...all documentation for the above road closure, there being no indication on available advertisements of who was actually responsible for the 'street party'.

The Council responded with:

This was applied for by the Tredworth Tenants and Residents Association and was processed as part of our order for the Queen's 90th Birthday Celebrations.

You do not feel that this can be all the documentation held in relation to this matter and have also submitted some further questions:

Was a fee due in return for the closure?
What was the precise time of closure, and re-opening?
Is the person who applied on the association's behalf named, or is that the only identification available?

I have now completed my investigation into your complaint and can provide the following information:

Please find attached copies of the documentation the Council holds in relation to this matter. I apologise for this documentation not being provided in our original response to you.

We have carefully considered your request and have come to the decision that some of the information is personal data as defined by the Data Protection Act 1998; it is

The road was closed between 10:00am and 6:00pm.
