FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

The Dog Fouling (Scotland) Act 2003, section 5 (1) (b) allows for Police Officers to issue a Fixed Penalty Notice in relation to persons failing to pick up their dogs foul, in certain circumstances. In each year since the formation of Police Scotland in April 2013, I would like to know how many of these Fixed Penalty Notices have been issued by Police Scotland.

Number of Dog Fouling Crimes: Scotland

From: 1 April 2013 - 31 March 2015

2013/14 2014/15

Dog Fouling 113 79

All statistics are provisional and should be treated as management information. All data have been extracted from Police Scotland internal systems and are correct as at 3 March 2016.

Data was abstracted from the Static Pot via Date Raised, no crimes and duplicated records excluded.

Please note that the above figures represent the number of crimes reported and dealt with by the police and not fixed penalty notices. Regarding the issuing of fixed penalty notices, I regret to inform you that I am unable to provide you with the information you have requested as not all dog fouling offences are dealt with by the police and that local council enforcement officers issue fixed penalty notices for this. Thus for this part of your request the information you seek is held by the various local authorities. We are therefore unable to answer this part of your request as the information is not held. Section 17 of the Freedom of Information (Scotland) Act 2002 is therefore applied – information not held.
