- 1. How many people were arrested on suspicion of drink driving in 2018?
- 2. How many people were arrested on suspicion of drug driving in 2018?
- 3. How many people were arrested on suspicion of drink driving in 2017?
- 4. How many people were arrested on suspicion of drug driving in 2017?
- 5. How many people were arrested on suspicion of drink driving in 2016?
- 6. How many people were arrested on suspicion of drug driving in 2016?

Result of Searches

Following receipt of your request, searches were conducted within Derbyshire Constabulary to locate any relevant information. The searches located some information relevant to your request.

Decision

In relation to this data please note the following:

The data has been extracted from the Constabulary's System which is, to all intent a
 'living' system in that it is constantly being updated. As such the data can only be
 verified for the date/time extracted.

- The data relates to:
 - ✓ Custody Records with Arrest date between 21/6/2016 & 31/1/2019, excluding 'Voluntary Attendance' & showing Primary Arrests only, with Offence Desc (Arrest) related to drug driving, recorded by Agency owner Derbyshire at Derbyshire Custody Suites
 - ✓ Custody Records with Arrest date between 21/6/2016 & 31/1/2019, excluding 'Voluntary Attendance' & showing Primary Arrests only, with Offence Desc (Arrest) related to drink driving, recorded by Agency owner Derbyshire at Derbyshire Custody Suites
- Police forces in the United Kingdom are routinely required to provide statistics/data to
 government bodies and individuals. However, the systems used for recording these
 figures are not generic, nor are the procedures used locally in capturing such data. It
 should be noted that for these reasons this Constabulary's response to your questions
 should not be used for comparison purposes with any other response you may receive.
