#### Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

### Request

I would like you to attach a copy of all of the annual data statistics for drink driving in 2018 only.

## **Clarification sought**

Although the data requested is held electronically by PSNI, it is held collectively for both 'drink and drug driving'. Due to the PSNI recording system to extract the data specifically for 'drink driving' would require a manual trawl of all these records and this process is estimated to exceed the FOI legislative cost of 18 hours.

# **Clarification from Requester**

Drink and drug driving statistics for 2018 suits me. If you can provide that I'll take it.

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
