FREEDOM OF INFORMATION ACT 2000 - INFORMATION REQUEST

Thank you for your request for information received by the Council on 23rd January 2018. It has been assessed and the following information is provided in response, but it has been renumbered as there appeared to be two b) questions in your original:

- (a) addresses of all Registered Residential HMO properties that are within your council's area; and
 - (b) the maximum number of occupants that each property referred to in (a) is licensed to hold
 - (b) now c) the last actual registered number of occupants that each property referred to in (a) holds
 - (c) now d) the date each of the properties in (a) was first registered as HMO
 - (d) now e) the names of the owners/licence holders of those properties referred to in (a)

Please can you provide me with the following information:

- a) addresses of all Registered Residential HMO properties that are within your council's area; and*
- b) the maximum number of occupants that each property referred to in (a) is licensed to hold*
- e) the names of the owners/licence holders of those properties referred to in (a)*

With regards to points a, b and e, please find attached the most up to date list of licensed properties within the Borough as of 3rd January 2018, which will answer these points.

- c) the last actual registered number of occupants that each property referred to in (a) holds*

Unfortunately, this cannot be answered as we do not require updates on occupation levels for any tenancy changes. We assess the properties to ensure that they are not over occupied and in breach of the licensing conditions.

- d) the date each of the properties in (a) was first registered as HMO*

This cannot be answered as we do not have a system/database to provide this information on such a scale; however, we can supply the details on a case by case basis.

You are free to use this information for your own use, including for non-commercial research purposes. It may also be used for the purposes of news reporting.
