Your Information Request
Freedom of Information (Scotland) Act 2002 ("FOISA")

I refer to the email of 3 April 2018 in which you requested various information in relation to Early Years and Education courses.

I have treated your request as a request for information under section 1 of FOISA. An application for information under section 1 of FOISA requires that a public authority releases all information held, subject to any applicable exemptions. Under FOISA, public authorities have twenty working days following the date of receipt of the request to respond to an applicant. The deadline for receipt of the response to your request is therefore 2 May 2018.

Right to request a review under FOISA
