Your request was received on 3 December 2017 and I am dealing with it under the terms of the Freedom of Information Act 2000 ('the Act').

You asked:

*Can I please have the admissions scores of Eccs for the last admissions cycle, distinguished between*


- 1) applicants without interview*
- 2) Applicants with interview and no offers*
- 3) And offer holders*

We do not hold interview information (all undergraduate interview processes are arranged by the individual Cambridge Colleges, each of which is a separate legal entity and public authority under the Act) or ECCA scores until an offer is made. As such we can only answer question 3; this information is attached. Please note that the attached document should not be copied, reproduced or used except in accordance with the law of copyright.
