# Information Request – Effect of Trump International Golf International Scotland on Sand Dunes at Foveran Links

Thank you for your information request, which we received on 15 September. We have considered your request under the Environmental Information (Scotland) Regulations 2004 ('the EIRs').

#### **Your Request**

"Could you please provide me with any information related to how the development of Donald Trump's golf course affected the sand dune system at Foveran Links, Aberdeen, and how the course was constructed in a way to counteract and ultimately prevent the moving of the dunes? This is in relation to the site imminently losing its SSSI status.

## **Our Response**

We have carried out a detailed search of the information we hold, and we have identified three key documents that meet the terms of your request:

- 1. Foveran Links SSSI Nature Conservation Act (NCA) Review Earth Sciences
- 2. Foveran Links SSSI Nature Conservation Act (NCA) Sand Dune
- Foveran Links SSSI Review of SSSI Notification Following Creation of Menie Links Golf Course

Copies of the documents are attached along with this letter. We have marked out (redacted) some personal data in the documents. Releasing the personal data into the public domain in response to an access to information request would breach the Data Protection Act 2018. We are therefore withholding the information under EIRs Regulation 11(2) (Personal data). We also redacted some information because it is not about how the golf course affected the sand dunes, and so is outwith the scope of your request.

I hope this information answers your query – you are welcome to contact us again if you are looking for any more specific information on Foveran Links.

### **How We Handled Your Request**

We believe you have asked for environmental information as defined in the Environmental Information (Scotland) Regulations 2004 ('the EIRs'), so we are dealing with your request under those regulations. To be able to use the EIRs, we must apply an exemption under section 39(2) of the Freedom of Information (Scotland) Act 2002 ('FOISA'). The Scottish Information Commissioner's guidance recommends that public authorities apply this exemption to environmental information and handle requests under the EIRs.
