Thank you for your email.

In response to the query, please ensure there is sufficient width of 3.1 at the gates/entry point if there are any at the alternative entrance/exit. The surface must be hard standing so that it is able to take the weight of the fire appliance (12.5 tonnes). This emergency path should be kept clear for emergency access at all times. The grasscrete removal is not an issue providing the width is maintained.


## Dear Hampshire Fire and Rescue Service

I refer to the Brislands Lane residential development in Four Marks and in particular to the developer's proposed change to the emergency access lane from Brislands Lane. The approved scheme had an access lane of 3 metres in width beyond which was a grasscrete strip on either side (see attached plan). The developer has requested that the grasscrete strips be removed but still maintain a 3m wide emergency access lane. I've attached the developer's email and plan.
