
Please note that care home residents typically have complex needs, and deaths cannot necessarily be contributed to concerns which lead to investigations.

If you wish Midlothian Council to review its actions and/or decisions with respect to your request for information, you should write to the Director whose name is printed at the top of this letter. Thereafter we will arrange for your application for review to be considered. We will write to you informing you of the decision by not later than twenty working days after receipt of your request requiring that a review be made. By virtue of section 21 of the FOISA, you will be provided with a statement of reasons for arriving at the decision made.
