#### Section 40(2): Personal Data:

You will notice that some details from the documents we are disclosing are redacted.

Section 40(2) provides for an exemption where the information requested constitutes personal data as defined by the Data Protection Act 2018 (DPA), and where release of the information requested would breach one of the data protection principles. The information contained in the requested information falls within the description of personal data as defined by section 1 of the Data Protection Act 2018 (DPA) because the information relates directly to an identifiable living individual.

We have also relied upon section 40(2) in some instances in removing names and contact details of junior staff within the Electoral Commission. This is because they would not reasonably expect their information to be released.

#### Section 21: Information accessible to the applicant by other means:

Section 21 provides for an exemption where the information is reasonable accessible to the applicant by other means. You are able to access the information requested under questions 3 and 4, and part of question 2, by visiting the Commission website, via the links provided to you.

Section 21 of the FOIA is an absolute exemption and therefore does not require us to consider whether or not it would be in the public interest for the information to be released.

I trust that this information satisfies your request. The Commission strives to be an open, transparent authority, but in some circumstances we cannot responsibly release requested information, and we ask for your understanding in this regard.

Thanks for your query.

On polling day for elections or referendums since the Scottish independence referendum in 2014, Facebook ran their 'I'm a voter' button initiative. On these occasions, Facebook asked for our consent to include a link to our neutral voter information website, as the best source of reliable information for voters on polling day. This website (which you can see at <a href="https://www.yourvotematters.co.uk">www.yourvotematters.co.uk</a>) provides information and advice to voters including on how to cast their vote, how to find their polling station and how to contact the elections team at their local council.

The Commission welcomes the efforts of any organisation which directs people to accurate information about voting, so we were pleased to give our consent for this link, although consent was of course not required as this is a free-to-access public website. Advance notice of the initiative also enabled us to prepare for the potential increase in traffic to our website, so we could ensure a continuity of service for visitors to the site.

We welcome the support of a wide range of public, private and voluntary organisations in promoting voter registration and adding value to our own campaign activity; we provide resources for organisations to use and coordinate this through our Roll Call newsletter, which has over 1500 subscribers from local authorities, NGOs and other organisations. The FOI Act requires the Commission to disclose information in response to a request unless an exemption applies. There are two types of exemption in the FOI Act.
