As per the Contracts Finder notice our Energy Broker in 2018 was Apollo Energy Ltd who manage the energy suppliers on their framework.

The suppliers on their framework for this opportunity were: SWALEC, E.ON Energy, Opus Energy, Npower, Corona Energy and Haven Power.

**2. Actual spend on this contract/framework (and any sub lots), from the start of the contract to the current date**

£1,912,032.21.

**3. Start date & duration of framework**

The contract Start Date was 01/10/2018 and the end date is 30/09/2021.

There is no formal agreement for extension other than if a termination notice is not provided prior to the contract end date the provider can continue to provide a service on a standard energy tariff until a notice is provided.

The agreed strategy is for the contract to be renewed.
