Dear Domenic Italiano,

Thank you for your Freedom of Information (FoI) request received on 11 January. You asked:

I'm alleging a crime has been committed. DWP don't hold prosecuting powers so, would you reference the public available information dealing with the procedure for handing over information/evidence to the police (or designed prosecuting authority) where demonstrable a crime has been committed.

Regarding entitlements, do the HMRC have any part to play in protecting/controlling the public purse?

## **DWP Response:**

I can confirm that the Department for Work and Pensions does hold some of the information you requested.

I have interpreted your first question to relate to the prosecution process in cases of suspected benefit fraud.

Fraud Investigators (Fl's) employed by DWP's Counter Fraud, Compliance & Debt Directorate (CFCD) investigate allegations into Benefit Fraud. Once sufficient evidence has been obtained that an offence has been committed DWP will, in line with their Prosecution Policy, decide how the case should be dealt with.

In cases where DWP considers prosecution to be appropriate evidence will be submitted to the Digital Case Management Unit (DCMU) who are responsible for conducting an administrative check on the prosecution file that has been prepared to the National File Standard by CFCD. DCMU is the conduit for operational correspondence between the DWP and Crown Prosecution Service (CPS) as the case progresses. All evidence is uploaded electronically by DCMU.

The ultimate decision to prosecute is taken by an independent body. In England and Wales this is Crown Prosecution Service (CPS); in Scotland the Crown Office and Procurator Fiscal.

CPS will need to be satisfied that there is enough evidence to provide a realistic prospect of conviction against the Defendant on each charge and that that it that it is in the public interest to prosecute the claimant. If it isn't in the public interest to refer a case, DWP will look at alternative options.
