The meeting hasn't changed any timescales from what we have previously discussed (in terms of consultation timescales) - we confirmed to the councillors / MP that the initial consultation will be for 60 days, and the second consultation (in the event of arriving at a minded too stage) for a minimum of 20 days (but will take a view of the situation at that time).

The main theme of the call related to effective communication as a result of the current COVID-19 restrictions changing our normal process.
