FREEDOM OF INFORMATION REQUEST

Thank you for your request received by us on 25 April under the Freedom of Information (Scotland) Act 2002 (FOISA) for:

"A copy of all information that PIRC hold that details how transphobia or other hate related conduct (written-words, spoken words, actions, behaviour) is to be objectively established and if such objective establishment is necessary to establish valid fear, distress or alarm of the victim of hatred.

The PIRC has considered this as a request under the Freedom of Information (Scotland) Act 2002 ("the Act"). An application for information held by public authorities under section 1 of the Act requires that a public authority release all information held, subject to any applicable exemptions. Public authorities have twenty working days following the date of receipt of the request to respond to an applicant. We received your request on 25 April 2014 and are required to respond in accordance with FOISA no later than 23 May 2014.

I have enclosed copies of the PIRC company policies on "Bullying & Harassment" and "Equal Opportunities" which outline the company information and how we would deal with any issues relating to transphobia. In terms of the police definition, we would normally refer to the Police Standard Operating Procedure (SOPs) when reviewing a complaint to determine details which they operate under for hate crimes. We would approach the police for a copy of the SOP for each case as they occur. If you wish to obtain a copy of Police Scotland SOP you can apply through their FOI unit, who can be contacted at:
