2. Within the Designated Estates, the Contractor will issue Parking Charge Notices and where applicable Abandoned Vehicle Notices to vehicles parked Without Lawful Authority from the following Designated Areas:
 - a) parking bays and car parks;
 - b) estate roads;
 - c) communal grassed and cultivated areas and any other common areas of the Designated Estate; and
 - d) or as otherwise specified by Homes for Haringey's Authorised Representatives

3. Within the Designated Areas the Contractor shall issue Parking Charge Notices and, where applicable issue Abandoned Vehicle Notices to vehicles parked Without Lawful Authority in accordance with the operating days and times for each Designated Estate as follows:-

Enforcement Service

8.00 am – 18.00 pm 6 days per week, Monday – Saturday, excluding Public Holidays, (or as otherwise specified by Homes for Haringey's Authorised Representatives).

Extended to 22.00pm on Tottenham Hotspur mid week stadium usage days within designated North Tottenham areas.

4. Unlicensed Vehicles at Broadwater Farm

The Contractor shall issue Abandoned Vehicle Notices to vehicles parked Without Lawful Authority including those causing an obstruction from the following Designated Areas:-

- a) parking bays and car parks
- b) estate roads
- c) communal grassed and cultivated areas and any other common areas of the Designated Estate; and
- d) or as otherwise specified by Homes for Haringey's Authorised Representatives

and in accordance with the operating days and times as given in 3 above.

Additional geographical areas are likely to be identified by Homes for Haringey's Authorised Representatives for inclusion in the future.

5. Unlicensed Vehicle Removals from other 'Haringey Housing Land'

Upon receipt of notification of an unlicensed and / or abandoned vehicle the Contractor will issue Abandoned Vehicle Notices and remove upon notice expiration, where applicable, vehicles parked Without Lawful Authority on all

'Haringey Housing Land' that is not included in the designated estates in 1 and 4 above.

6. Tow Truck Provision

Specific, identified vehicles are required to be moved from time to time when they remain on a site where notice of works has been given by Homes for Haringey and vehicle owners have failed to move them. Upon advance notification of this requirement by Homes for Haringey's Authorised Representatives, the Contractor will arrange for a tow truck to be on standby and despatched upon demand to move identified vehicles to the closest, safe location.
