Thank you for the PGN spreadsheet. It is clear that some of these are within my area. We have noted that some of the existing JSP 850 which we are re-visiting have references to the MOD Practitioner Guides eg designated sites - I note that in more recent leaflets refer to these as DIO Practitioner Guides. These are all out of date so the questions are: who sponsors / owns them? Who & when will be asked to update them? or should the content be updated and transfer to JSP guidance section (which I'm guessing not!)? The references to these have been left in - although most are in the Natural Environment areas yet to be reviewed.

Of the 9 sections you originally provided to me for review we have now reviewed and made comments to 6. These are now attached. Where no comments/changes are made then there is no change required. Please note the Public access review has highlighted a major policy change which has been driven by legal advice from CLS but which will need ratification by FMC as appropriate. We have highlighted the text and included the legal advice in the attached access email. Equally the landscape section also contains a question on MOD dark sky policy which requires FMC guidance as policy leads.

The outstanding 3 are:

Natural Environment; Coastal Marine Planning and Conservation Groups. These will be reviewed and comments passed on to you in early July. This is simply down to a lack of resource in my ecology teams and other priorities.
