Further to [REDACTED] email, having looked back at the JSP 850 document I note that we have not included anything which ensures we are including and covering the requirements of the Equalities Act 2010, as required as a public body / service provider.

In the documents current form my suggestion is that a section titled "Access for All" should sit between the **Policy** and **Liner Access**

I want to ensure we are in line with other government departments in ensuring we are working towards providing access for all. Can I suggest the following wording, which incorporates text from [online supporting documentation](#).

i720In delivering the MOD public access and recreation policy it should be ensured that due regard is given to the aims and principles of the Equality Act 2010.

i720The Equality Act requires public bodies to have due regard to the need to:

i720• eliminate unlawful discrimination, harassment, victimisation and any other conduct prohibited by the Act;

i720• advance equality of opportunity between people who share a protected characteristic and people who do not share it;

i720and

i720• foster good relations between people who share a protected characteristic and people who do not share it.

Can I also ask what scope there is to include reference to national health and wellbeing policy? There is an increasing suite of fact based information that clearly demonstrates the importance of outdoor recreation for health and wellbeing. If possible I'd like to ensure we are engaged with this given it's importance and relevance to the public at large as well as service personnel and MOD staff.
