Your email dated 15th February 2017 is considered to be a request for information under the Freedom of Information Act (FOIA) 2000. You requested the following information:

Please supply the service histories for 62FL47, 73FL77, 73FL95 & 73FL97 under the Freedom of Information Act.

I can confirm that the Ministry of Defence (MOD) holds information relevant to your request. Unfortunately, following the closure of MERLIN it is only possible to retrieve information held on the archived version of the database, which is attached.
