Your email dated 12 April 2018 is considered to be a request for information under the Freedom of Information Act (FOIA) 2000. You requested the following information:

Please could you provide, under the Freedom of Information Act, the JAMES maintenance records for my ex-military Land Rover 90 GS, registration 56KK19.

*Maintenance History List
Repair Action List
Usage History*

I can confirm that the Ministry of Defence (MOD) holds some information relevant to your request. Some information falls within scope of section 40(1) of the FOIA. This states that information is exempt if it constitutes personal data. Where this is the case, the information has been redacted.

Section 16 of the FOIA requires public authorities to provide advice and assistance to requesters, so far as it is reasonable to do so. You are advised that when vehicle maintenance data was migrated over from the MERLIN database to the JAMES database, some of the data from casted vehicles was either lost or corrupted. Therefore, the information provided in the maintenance record may be inaccurate.

This information supplied to you continues to be protected by copyright.
