Thank you for your email of 12th June 2016 which I can confirm is considered to be a request for information under the Freedom of Information Act (FOIA) 2000. You requested information on the following vehicle:

"ex military Land Rover 110 the military registration was 99-KE-42"

I can confirm that the Ministry of Defence holds information relevant to your request. Unfortunately, the MERLIN database is currently closed as its contents are undergoing archiving, prior to the shut-down of the system itself. Consequently, we're unable to produce the full MERLIN report but attached is a copy of the information that is available to us.

This information supplied to you continues to be protected by copyright. You are free to use it for your own purposes, including for private study and non-commercial research, and for any other purpose authorised by an exception in current copyright law. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
