7b. And, as part of the specials, is he paid merely expenses or an annual salary and, if so, how much?

This information is exempt by virtue of Section 40(2) (Personal information). Section 40(2) allows for personal data to be withheld where release would breach the third party's data protection rights.

However I can confirm that Specials of all ranks do not draw a salary but they are able to claim expenses.

8a. Why is Vanessa Jardine named as an additional ACC midway down the police structure planogram, but not on the Executive Team header?
