Thank you for your request for information which was received on 10 August 2020.

Your request was "1.Provide all the data, in date order if possible, collected and passed to you by Faculty under the contract mentioned above. I am happy to have this in DVD or CD format for Msft Windows or Linux pc.

- 2. Provide the specification for the work.
- 3. Provide all relevant invoices.
- 4. Provide a list of all those invited to tender for the job."

Your request has been considered under the Freedom of Information Act 2000.

Q1 & Q3

I can confirm that MHCLG does hold this information but it is exempt under section 43(2) of the FOI Act as disclosing it would be likely to harm the commercial interests of MHCLG and/or Faculty.

For Q1, the data requested could potentially be used to gain an insight into the methodology that Faculty used to deliver this work and would therefore be likely to harm their own commercial interests.

For Q3, detailing key financial information from this contract and Faculty's resourcing for this project (evidenced by the day rates for the different roles on the invoice) would allow third parties to establish the financial and commercial impact or risk to MHCLG and Faculty.

MHCLG wishes to protect its commercial interests and ability to participate in future commercial activity. In order to do this, we are withholding key commercial information which would show the financial position of both parties. MHCLG also has a responsibility to protect information that provides details of Faculty's sources of competitive advantage in competing for contracts, as well as details of Faculty's

performance against its obligations. The disclosure of this information would be to the detriment of present and future business activities for both parties.

Information falling within this exemption must still be provided however unless it is not in the public interest to do so.

MHCLG recognises the need for openness and transparency within Public Authorities and the current interest in this contract.

As part of the Transparency Agenda, MHCLG publish data on all money spent with suppliers over £250 and the total spend on this contract will be published in due course. Therefore in this instance, the public interest in releasing individual invoices, is outweighed by the damage that would be done to MHCLG in obtaining best value for money in its current and future negotiations. Disclosure of the data and invoices would also be prejudicial to Faculty's interests by allowing competitors to gain an advantage when competing for future contracts.

We have therefore decided that, on balance, it is not in the public interest to disclose this information at this time.
